The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

The number of sections and students shall be restricted as per the actual facilities in the school.

For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet.

**Important Notes :** 1. The total number of section of the school shall be restricted to 17 (as per prescribed limit) as per the number of class rooms reported during inspection and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law. 2. The school should restrict the enrolment in proportion in classroom size of 400-500 sq ft and greater than 500 sq ft. 3. The school has uploaded the one page of recognition certificate dated 30/03/2018 from class 1 to class 8 which was valid upto 29/03/2021, the signed copy has not been uploaded. However the

school has uploaded the signed copy on mandatory public disclosure link. The school has also uploaded the recognition certificate dated 08/05/2013 and a newspaper cutting wherein it is mentioned that after completion of three years the recognition will be considered as permanent if there is no adverse report against the school. 4. The school has mentioned in the application that the land is owned by way of Gift Deed whereas in Land certificate, it is mentioned the land is owned by way of Gift Deed and Leas Deed. The lease period is not mentioned in the land certificate dated 24/03/2021 uploaded by the school. However the school has uploaded the lease deed on mandatory public disclosure link wherein it is mentioned that the school is owned 670sqm (out of total area 6098sqm) by way of lease deed for a period of 30 years from 24/03/2021. The complete school name is seen on the land certificate as the name is overlapped by digital signature in the land certificate. Hence the school is required to upload a fresh copy of land certificate showing the complete details. 5. As per self-declaration, the trust deed is signed by Sub Registrar Kerakat Tehsil but no signature or seal is seen on the trust deed uploaded by the school. However the signed copy is uploaded on mandatory public disclosure. 6. From the inspection video it is seen that no separator is there in boy's toilet. Hence the school is directed to fix the separators in boy's toilet within three months. 7. The school is required to fulfil the observations raised by the IC members i.e. MORE BOOKS AND MAGZINE, LEADERSHIP NEED TO BE ADDED, CONSTRUCTION OF RAMPS TO ACCOMODATE THE DISABLYED STUDENTS IS NEEDED, DEVELOPMENT OF TEACHERS RESOURCE CENTRE IS ADVISED. MORE GIRLS STUDENTS SHOULD BE ENCOURAGED TO MORE AND MORE SPORTS ACTIVITIES FOR THAT MONTHLY SPORTS COMPITIION CAN BE CONDUCTED. 8. The school is required to renew all the mandatory certificates from time to time. 9. The school is directed not to remove the essential documents uploaded on mandatory public disclosure of the school website and e-governance link in future.

School is required to appoint special educator & wellness teacher as per affiliation bye laws.
